In pursuance of BOP's commitment towards nation building and revival of our historical references, a project of making a dairy on Pakistan Movement titled "Making of Pakistan" has been initiated.

Applications are invited from well-experienced firms possessing experience of designing/printing of similar projects with all relevant ingredients. Scope of works shall include designing & printing of specialized dairies. Firms with experience of making of such documents/dairies must also fulfill the following criteria:

- 1. The firm must have enough photos, pictures & relevant write-ups
- 2. The firm should have to their credit making of such documents/dairies for corporate clients.
- 3. Experience in making such historical documents/dairies

The dairy is expected to be a landmark state of the art memorable document reflecting Heritage & pictorial view of Pakistan Movement.

Interested firms are required to submit their sealed applications duly supported with the below mentioned information / documents. Last date for submission of application is December 2^{nd} , 2016.

- i. Name, permanent mailing and email address of the firm.
- ii. Status of the firm (proprietorship, partnership, Ltd Co. etc. (Documentary evidence should be attached)
- iii. Year of enlistment / registration of the firm with relevant Authority (Documentary evidence should be attached)
- iv. Experience of the firm (minimum 5 years with documentary evidence).
- v. Valid registration certificate from printing press association.
- vi. Provision of such Services to banks / multinational companies for making such historical documents/dairies (Documentary evidence should be attached).
- vii. Registration with Income Tax department, Sales Tax.
- viii.Original affidavit of no litigation on stamp paper of Rs. 200/- duly attested by Oath Commissioner / Notary Public.
- ix. Bank Certificate / Bank Statement not over 3 months old reflecting annual credit turnover of at least Rs. 3.00 million.

ADDITIONAL TERMS AND CONDITIONS

- 1. Firms fulfilling above mentioned criteria may submit their applications.
- 2. Concealment of facts will be sufficient cause for disqualification.
- 3. Applications of Firms not submitting complete documents / not fulfilling the minimum criterion will not be considered.
- 4. Shortlisted firms will be required to make presentation with details in terms of Photos, pictures, write-up and selection will be based on marks obtained regarding design, photo/pictures, write up and overall package of document/dairy through Bank's Management. However the firm will not claim any charges against these presentations.
- 5. Bank has the right to reject all applications without assigning any reason as per PPRA Rules.
- 6. Bid documents are immediately available after this publication. Firms fulfilling above criteria may obtain documents free of cost, on any working day (Monday to Friday between 9:00am to 5:00pm) till 1-12-2016.
