Interested firms are required to submit their applications as per pre-qualification documents along with the following documents showing their credentials, expertise and financial strength:

REQUIREMENTS:

1. Firm must have minimum of 5 years recent relevant experience for Lot No. 1 and 3 years for Lot No. 2. Company profile must clearly show year of establishment. (Documentary evidence should be attached).
2. Detail of capability/capacity with respect to personnel, equipment and plant (for Lot No. 1).
3. The firm must have their own production facility equipped with state of the art machinery/equipment (for Lot No. 1).
4. Detail of similar types of works completed in Banks and other organization during the last two years with documentary evidence. Certificate/ Purchase order with invoice for each project should be attached.
5. Bank's technical team will visit Project sites and nationwide offices of shortlisted firms (if required).
6. Bank Certificate/Statement not over 6 months old confirming annual credit turnover of at least Rs. 2 Million.
7. Proof of Sales Tax Registration, NTN Certificate.
8. The word pre-qualification for each LOT i.e 1 or 2 shall be clearly written/ marked on each sealed envelope.
9. Affidavit on stamp paper of Rs. 100/- signed by the authorized signatory of the firm to the effect that the firm is not black listed and not indulged in litigation with any Government Department/Private Organization and is not a tax defaulter etc.
